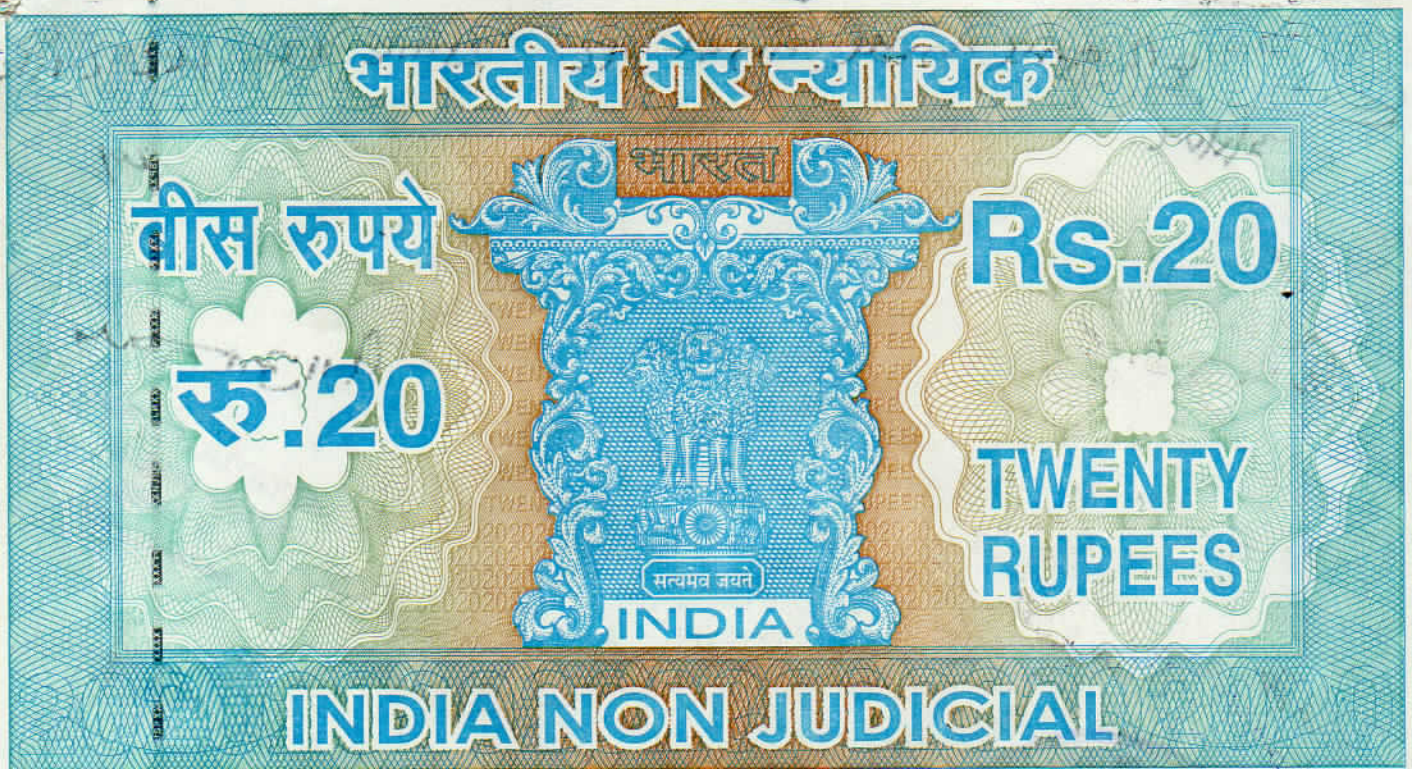

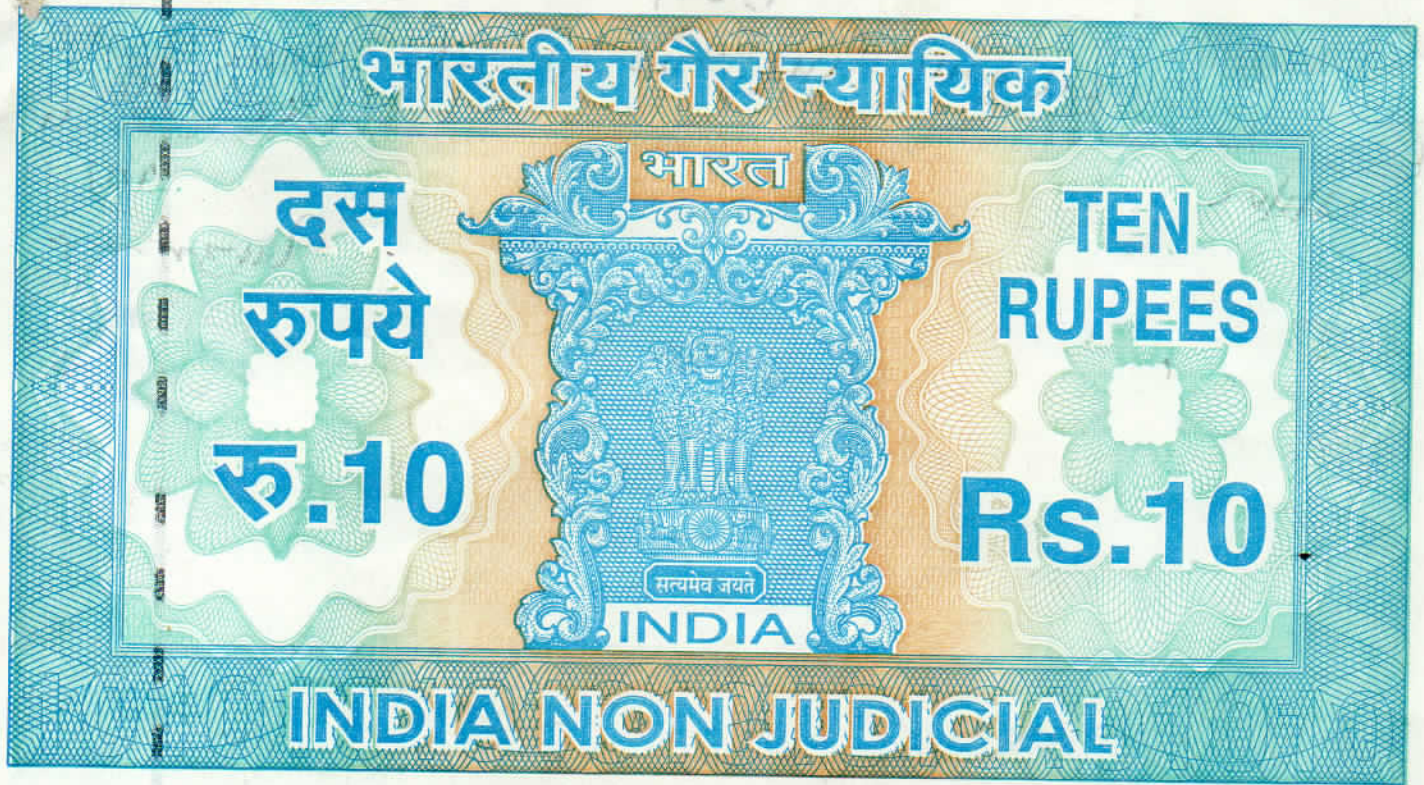

2. The head office of the trust shall be situated at Ex-Bajaj
Show Room, IInd Floor, Near K.B. Women's College,
Hazaribagh, and the address may be changed as and when found
necessary by the TRUSTEES.

3. The aims and objects of the trust shall be any of the following;

(a) Advancement and propagation of education and
learning including establishment, maintenance and support
of schools, college, coaching classes and other educational
institutions.

(b) To make provisions to advance the course of the and
impart Nursery, Primary, Secondary, Higher, Commercial,
Industrial, Technical, Engineering, Medical, Law, B.Ed.,
Polytechnic, Physical Training etc. and all or any other types or
kinds of educations including professional and vocational
training educations etc.

(c) To establish, Maintain, take over management, administer
or run any institution, colleges, engaged in imparting of education
to students up to any level that may be found necessary and / or
desirable.

4. TRUSTEES :-

(b) The other trustee shall retire by rotation in two at a time, the first to commence three years from the date of the Trust Deed. The retiring trustee will be eligible to be co-opted for further period.

(c) The Author of the Trust and trustees shall at their discretion co-opt any person/ or persons who may be helpful in achieving the object of the trust as a trustee.

(d) The maximum number of the trustees particularly the life member shall not exceed seven.

(e) There will be an Advisory Board whose name finds place in the minutes books.

(f) A trustee shall cease to hold office of the trust on the trustee becoming insane or luncatic.

MANAGEMENT :-

(a) The management, control of the property and affairs of the trust shall be vested in the trustees will full power and

conditions as may be thought expedient.

(b) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this trust is authorised to amalgamate.

(c) To manage trust funds and collect and recover, the interest and profit there of, and to pay there out expenses of collection and other outgoing if any.
